Cancellation Policy

1. Registrations cancelled more than 60 days before the event will be refunded 80% of the registration fee.
2. Registrations cancelled less than 60 but more than 30 days before the event will be refunded 50% of the registration fee.
3. Registrations cancelled less than 30 days before the event will not be eligible for a refund.
4. Full registrants who fail to cancel and do not attend will not be eligible for the refund.
